LEGAL BASES OF THE "VELCA & BIT2ME" DRAW

1.- ORGANIZING ENTITY

BITCOINFORME, SL (hereinafter **Bit2Me**), with address at Calle Germán Bernacer, 69, 03203, Elche, Alicante, SPAIN and with N.I.F B-54835301, registered in the Mercantile Registry of Alicante, volume 3828, sheet 110, Inscription 1 with page number A-143230, has organized the campaign called "Velca & Bit2Me", which will be carried out in accordance with the provisions of these Bases.

2.- PURPOSE

This "Velca & Bit2Me" campaign is developed within the framework of the partnership between Bit2Me and "VELCA MOTOR" (RHINO ELECTRIC MOTORS, SL).

In this sense, the draw called "Velca & Bit2Me" has been organized with the aim of rewarding, with **two** "Velca Fisterra" electric bicycles, participating Bit2Me users who buy a minimum amount of 2,000 B2M and send them to the Bit2Me Earn service. (keeping the B2M on Earn until the draw takes place).

Likewise, among the participants of the "Velca & Bit2Me" draw (including those who are awarded the Velca Fisterra bicycles), the "Engagement Olympics" action will award €4,000 in BTC to those users who actively participate in Bit2Me's Social Networks (Twitter, Discord, Telegram and Instragam) as indicated in these Bases.

3.- PERIOD OF PARTICIPATION

The period to participate in the campaign will be from Monday, June 27, 2022 to Sunday, July 3, 2022, both included, through registration in the registration form. https://landing.bit2me.com/sorteo-velca from the Bit2Me website https://bit2me.com/, and the Bit2Me Social Networks (Twitter, Discord, Telegram and Instagram).

4.- RULES AND CONDITIONS OF PARTICIPATION

4.1. "Velca & Bit2Me"

- 3. Acquire the minimum amount of 2,000 B2M in the Wallet of your account registered and verified in https://bit2me.com/ during the draw entry period.
- 4. Send the minimum amount of 2,000 B2M acquired during the draw participation period to the Bit2Me Earn service (https://bit2me.com/es/suite/earn).

It is not allowed to participate with B2Ms acquiered prior to the start of the campaign or to take out B2Ms already in Bit2Me Earn prior to the start of the draw and re-transfer them to participate in the draw.

5.- SELECTION OF AWARDS AND COMMUNICATION OF THE"VELCA & BIT2ME" DRAW

On Monday, July 4, 2022, the draw for the 2 Velca Fisterra bicycles will be held through a platform of random winners (https://www.random.org/lists/).

2 winners will be chosen and 2 substitutes will be established among all the participants who meet the requirements indicated in the previous clause.

Bit2Me will contact the winners by telematic means. The means of contact will be through an email (from media@bit2me.com) to the address of the winner of the draw, which will correspond to the email associated with the registered and verified account on the Bit2me website. https://bit2me.com/. If within 7 calendar days after the contact the winner has not responded or contacted, the prize will go to the substitute, who will also have 7 days to respond. Once the prize has been assigned to the substitute, the previous winner will lose the right to claim the prize.

Likewise, the winners of the draw will be communicated on July 4, 2022 through the Bit2me social networks.

6.- DYNAMICS AND CHARACTERISTICS OF THE DISTRIBUTION OF BTC TO THE WINNERS OF THE "ENGAGEMENT OLYMPICS" ACTION

Among all those participating in the "Velca & Bit2Me" draw, <u>including those who are</u> <u>awarded with the Velca Fisterra bicycles</u>, 4 winners will be chosen among the that the amount of €4,000 in BTC will be distributed, € **1,000 in BTC for each winner**.

- 4 winners will be chosen and a list of 4 substitutes will be established among all the participants of the "Velca & Bit2Me" draw who, in addition, meet the requirements of clause 4.2. of these Bases and are winners according to the following criteria:
 - **Telegram:** Highest number of **upvotes** in a publication of the user participating, making his proposal for future activities in Telegram for the community.
 - Discord: Highest number of converted invitations to the Bit2Me Discord channel "Bit2Me (B2M Mission)".

8.- FISCAL OBLIGATIONS

In accordance with the provisions of the regulations that regulate the prizes obtained, those whose value exceeds €300 will be subject to payment on account or withholding by the prize winner. On the other hand, prize winners for a value equivalent to €300 or less than €300 will not be subject to withholding.
