

## LEGAL BASES "5 DAY FIDELITY CAMPAIGN"

### 1.- ORGANIZING ENTITY

BITCOINFORME, S.L. (hereinafter Bit2Me), with address at Calle Germán Bernacer, 69, 03203, Elche, Alicante, SPAIN and with N.I.F. B-54835301, registered in the Mercantile Registry of Alicante, in volume 3828, folio 110, Inscription 1 with Sheet A-143230, has organized the campaign called "5 day Fidelity campaign", which will be developed in accordance with the provisions of these Terms and Conditions.

### 2.- OBJECTIVE

The objective of the "5 day Fidelity campaign" is the promotion of the services represented by the B2M TOKEN token or cryptocurrency, rewarding with an Airdrop of 3.808 TON, whose market value is 5.000\$ approximately (calculated on 05/26/2022, check its price to know the current value) to the community of users who acquire a minimum of 300 B2M during the 5 days of campaign and transfer them to the Bit2Me Earn service (keeping the B2M in Earn at least until the last day of campaign).

### 3.- PARTICIPATION PERIOD

The participation period will be from Monday, May 30, 2022 until Friday, June 3, 2022, both included, through the Bit2Me website <https://bit2me.com/>.

### 4.- RULES AND CONDITIONS OF PARTICIPATION

The campaign is open to all those individuals, of legal age, residing in any country supported by the Bit2Me platform, which can be found at the following link: <https://bit2me.com/en-el-mundo>, and who meet the following requirements:

1. Have a registered and verified account on the website of <https://bit2me.com/>. We remind you that verification can sometimes take several days and is subject to compliance with current legal regulations.
2. The participant must purchase the minimum amount of 300 B2M per day in the Wallet of his/her registered and verified account on <https://bit2me.com/> during the period of participation in the campaign (5 days).
3. Transfer the minimum amount of 300 B2M per day acquired to the Bit2Me Earn service (<https://bit2me.com/es/suite/earn>) during the period of participation in the campaign (5 days).

It is not allowed to participate with B2M acquired prior to the start of the campaign or to take out B2M that are already in Bit2Me Earn prior to the start of the campaign and transfer them back to participate in the campaign.

Bit2Me employees and profiles that have intentionally manipulated their participation are not eligible to participate.

At the end of the campaign, participants must keep the B2Ms acquired during the participation period stored in the Bit2Me Earn service. The participant may change his/her participation during the active period of the campaign, provided that at the time of termination he/she has a minimum amount of 300 B2M in Bit2Me Earn that have been acquired during the period of participation in the campaign.

Bit2Me reserves the right to make changes to the campaign during its development, should any cause arise that would prevent it from being carried out successfully or in order to improve its progress.

## **5.- DYNAMICS AND CHARACTERISTICS OF THE DISTRIBUTION**

The prize of the present campaign consists of an Airdrop of 3,808 TON whose market value is approximately \$5,000 (calculated on 05/26/2022, check its price to know the current value) that will be distributed among all those users who acquire and transfer to Bit2me Earn at least 300 B2M daily during the 5 days of the participation period.

In this regard, Bit2Me will allocate the amount of 753 TON per day, whose market value is approximately \$1,000 (calculated on 05/26/2022, check your quote for the current value), which will be divided among all participants who meet the daily requirements described in the previous clause.

The TONs allocated on a daily basis to each participant will be sent to the Wallet of their registered and verified account at <https://bit2me.com/>. The distribution of the allocated TONs will take place during the 3 business days following the end date of the campaign (June 4, 2022).

The amount of TON assigned will be those that the participant has accumulated for the days participated in the campaign, not being necessary the participation during the 5 days that the campaign remains active. Therefore, if the participant has participated during 3 days of the 5 days that the campaign remains active, he/she will receive, at the end of the campaign, the amount of TON corresponding to the 3 days of participation.

## **6.- TAX OBLIGATIONS**

In accordance with the provisions of the regulations that regulate the prizes obtained whose value exceeds 300€, they are subject to a deposit or withholding by the person who delivers the prize.

In the case of winners whose tax residence is in Spain, the amount of the payment on account or withholding for prizes paid in kind, in this case, for the amount of TON obtained as a prize, whose equivalent value in Euros is greater than 300 Euros, will be calculated by applying 19% to the result of increasing by 20% the value of the acquisition or cost to the payer.

On the other hand, to the winners who receive TON for a value equivalent in euros to 300€ or less than 300€, no withholding will be applied.

In the case of winners whose tax residence is in any other of the countries supported by the Bit2Me platform (<https://bit2me.com/en-el-mundo>), Bit2me will make a deposit on account on the amount of the prize if the Double Taxation Agreement between Spain and the country of tax residence of the winner so provides.

The winners will be responsible for their tax obligations, so Bit2Me will be exempt from any liability in this regard. Bit2Me is not responsible for any failure on the part of the winners that may occur due to the lack of communication, information or remission of the correct tax to the corresponding tax authority.

## **7.- PROTECTION OF PERSONAL DATA**

In compliance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (hereinafter, RGPD), in the Organic Law 3/2018 of 5 December on the Protection of Personal Data and guarantee of digital rights (hereinafter, LOPDGDD) and any other applicable data protection regulations, we inform participants that their personal data will be incorporated into a Database of common ownership and responsibility of the companies of the Bit2Me Group, whose purpose and legal basis is the management and participation in the campaign, as well as the maintenance of commercial relations by electronic means based on the legitimate commercial interest of the companies of the Bit2Me Group (you can consult the list of companies at [www.bit2me.com](http://www.bit2me.com)).

Participants in the sweepstakes have recognized the exercise of rights of access, rectification, deletion, limitation, opposition and portability of their data that may be exercised by sending an email to the address [rgpd@bit2me.com](mailto:rgpd@bit2me.com). Once the purpose of the processing has been concluded or the deletion of your data has been requested, the data will be blocked at the disposal of the Administration, Judges and Courts, for the periods of prescription of the legal actions that correspond for the processing produced in defense of our interests.

Similarly, participants in the campaign are informed that they have the right to withdraw their consent for commercial purposes for data processing by Bit2Me Group, and that they have the right to complain to the Spanish Data Protection Agency <https://www.aepd.es/es>.

## **8.- PENALTIES IN CASE OF FRAUDULENT USE**

Bit2Me reserves the right to shorten, extend, modify or cancel the "5 day Fidelity campaign" if it deems it appropriate or if special circumstances occur that prevent the realization of this or there are exceptional circumstances that prevent its realization.

Bit2Me is not responsible if any user/customer does not pass the process to have a verified Bit2Me account, or if, due to a possible high demand for the completion of the verification process of the Bit2Me account could not be completed before June 3, 2022.

Bit2Me reserves the right to take legal action against those who perform any act that could be considered as manipulation or falsification of the campaign.

## **9.- ACCEPTANCE OF THESE LEGAL BASES**

Participation in the campaign implies the acceptance of these legal bases. Any manifestation of non-acceptance of all or part of the present legal terms and conditions will imply the exclusion of the participant and, as a consequence, Bit2Me will be released from the fulfillment of the obligation contracted with this participant.
