

LEGAL TERMS OF THE PROMOTION

"Win 1 Ethereum with recurring purchases".

1.- Identification of the organizing company

The company Bitcoinforme S.L. (hereinafter **Bit2Me**) with registered office at C/ Germán Bernacer, 69, 03203, Elche, Alicante, Spain and with Tax ID: B54835301, has organized the promotion called "Cuesta de enero sin comisiones" (hereinafter the promotion) which will be carried out in accordance with the provisions of these Terms and Conditions.

2.- Object

La presente promoción tiene por objeto el sorteo de 1 Ethereum entre todas los usuarios que activen la funcionalidad de compra recurrente en cualquier criptomoneda con al menos 10€ de compra durante 4 semanas como mínimo en la plataforma Bit2Me (accesible en <https://bit2me.com> y en la APP "Bit2Me" en Android e iOS), durante el periodo de vigencia de la promoción.

En concreto, aquellos usuarios registrados y verificados en la plataforma Bit2Me que cumplan con los requisitos establecidos en la cláusula 4 de las presentes bases legales entrarán en el sorteo de 1 Ethereum para un usuario.

3.- Period of participation

The period of validity or participation in the promotion will be from Wednesday, March 15, 2023 until Wednesday, April 26, 2023, both included, through the Bit2Me platform (exclusively on the "Bit2Me" APP on Android and iOS).

4.- Rules and conditions for participation

The promotion is open to all individuals, of legal age, residing in any country supported by the Bit2Me platform, which can be found at the following link: <https://bit2me.com/en-el-mundo> , and who meet the following requirements:

1. Have a registered and verified account on the website of <https://bit2me.com/>. We remind you that verification can sometimes take several days and is subject to compliance with current legal regulations.
2. Make 4 weekly purchases of at least 10€ enabling the recurring purchase function, that is to say, make a total of 40€ in 4 weekly purchases between Wednesday March 15th and April 26th.

It is important to note that the period for the first weekly purchase must be between Wednesday, March 15 and Wednesday, March 29 in order to participate.

Bit2Me employees and profiles that have intentionally manipulated their participation are not eligible to participate.

Bit2Me reserves the right to make changes to the promotion during its development, if any cause should arise that would prevent it from being carried out successfully or in order to improve its progress.

In the event that any user has a technical problem in the process of execution of their recurring purchase, they can contact our Customer Service team by opening a ticket detailing their situation to study their case and maintain the possibility of participating in the promotion.

5.-Drawing of lots

All participants who meet the requirements indicated in clause 4 will participate in the draw that will take place between April 27, 2023 and Wednesday, May 4, 2023. **The prize will be delivered between Wednesday, May 4, 2023 and Wednesday, May 18, 2023** to the wallet of the user chosen in the draw. The winning user will receive an email to his/her email address.

6.- Tax obligations

The winning participant is responsible for any obligation to declare the prize to the competent tax authorities and to remit, accept or pay any taxes, fees, withholding and/or expenses of any kind that, by virtue of the application of tax regulations, may be applicable, being Bit2Me exempt from liability in this regard and with no obligation to provide tax advice. Any other expenses incurred, in addition to those mentioned above and that are incidental to the realization of the prize, is the responsibility of the winning participant.

In this regard, Bit2Me will make the necessary withholdings on account of the prizes awarded in accordance with the rules provided by the IRPF regulations (or IRNR regulations if applicable).

7. Protection of personal data

In compliance with the provisions of [Regulation \(EU\) 2016/679 of the European Parliament and of the Council of 27 April 2016 \(hereinafter RGPD\), in the Organic Law 3/2018 of 5 December, on the Protection of Personal Data and guarantee of digital rights \(hereinafter LOPDGDD\)](#) and any other applicable data protection regulations, we inform participants that their personal data will be incorporated into a Database owned and under the responsibility of BITCOINFORME, S.L. whose purpose and legal basis is the management and participation in the promotion, as well as the maintenance of commercial relations by electronic means based on the legitimate commercial interest of the companies of the Bit2Me Group (you can consult the list of companies at www.bit2me.com).

The participants of the promotion have recognized the exercise of rights of access, rectification, deletion, limitation, opposition and portability of their data that may be exercised by sending an email to the address rgpd@bit2me.com. Once the purpose of processing has been concluded or the deletion of your data has been requested, the data will be blocked at the disposal of the Administration, Judges and Courts, for the periods of prescription of the legal actions that correspond for the processing produced in defense of our interests.

The personal data marked with an asterisk in the registration form of the promotion are essential for the purpose stated, the absence of such data would imply the impossibility of registration and validation as a participant.

The participant guarantees that he/she is the owner of the personal data provided and that these are authentic. The participant will be responsible for the consequences of providing false data.

Likewise, participants in the promotion are informed that they have the right to withdraw their consent for commercial purposes for data processing by the Bit2Me Group, and that they have the right to complain to the Spanish Data Protection Agency <https://www.aepd.es/es>.

8.- Penalties in case of fraudulent use

Bit2Me will consider as fraud behaviors that Bit2Me deems as apparently abusive and/or malicious. Similarly it will be understood, by way of example, but not limited to, that abuse or fraud occurs when a participant is identified using a false identity or identities of third parties without their consent.

Bit2Me is not responsible for possible inappropriate or offensive content that users, at their own risk, may upload in the media that will be used for the development of the promotion.

Bit2Me is not responsible if any user/customer does not pass the process to have a verified Bit2Me account, or if, due to a possible high demand for the completion of the Bit2Me account verification process, it cannot be completed before the end date of this promotion.

The verification of any of these practices will result in automatic disqualification and prohibition from participating in the promotion,

Bit2Me reserves the right to take legal action against those who carry out any type of act that could be considered as manipulation or falsification of the campaign.

9.- Liability

Bit2Me reserves the right to make changes or cancel the promotion during its development, in the event of any cause that would prevent it from being carried to a successful conclusion or in order to improve its progress.

Bit2Me will be exempt from any liability for damages that may be due to the temporary lack of availability or continuity of the operation of the campaign, the defrauding of the usefulness that users may have attributed to it and access to the different pages and sending participation responses via the Internet. Bit2Me will also be exempt from the acts or

omissions of the participants that prevent their correct participation in the development of the promotion.

10.- Acceptance of the Legal Bases

Participation in the promotion implies acceptance of these terms and conditions. Any manifestation of non-acceptance of all or part of the present legal terms and conditions implies the exclusion of the participant and, as a consequence, Bit2Me will be released from the fulfillment of the obligation contracted with this participant.
