# TERMS & CONDITIONS OF THE PROMOTION"Special Promotion B2M Holders"

### 1.- Identification of the organizing company

This paragraph is identifying the organizing company of the promotion "Special B2M Holders Promotion". The company is Bitcoinforme S.L. (hereinafter Bit2Me) with registered address at C/ Germán Bernacer, 69, 03203, Elche, Alicante, Spain and with NIF: B54835301. The promotion will be carried out in accordance with the terms and conditions set forth in these bases.

# 2.- Objective

The purpose of this promotion is to grant a week of commission-free purchases on the Bit2Me platform (accessible at <a href="https://bit2me.com">https://bit2me.com</a> and on the "Bit2Me" app on Android and iOS) for current and new individual customers who access the promotion links and maintain 3,000 B2M for 5 consecutive days while the promotion is valid.

To be eligible for the commission-free campaign, users must maintain the necessary B2M funds they have purchased or already have on the platform for 5 days, either held in the wallet or using Bit2Me Earn services.

Failure to maintain the funds in the platform's services invalidates the right to participate in the commission-free week.

The funds can be held in both Bit2Me Wallet or within the service of Bit2Me Earn.



### 3.- Participation Period

The promotion period to maintain funds for 5 consecutive days will be from Thursday, June 15th to Friday, June 30th (both included), through the Bit2Me platform (accessible at <a href="https://bit2me.com">https://bit2me.com</a> and on the "Bit2Me" app on Android and iOS).

The validity period for the week of commission-free purchases will be from Monday, July 3rd to Sunday, July 9th (both included). The refund of commissions for all purchases made during that period will be made during the month of July 2023.

### 4.- Rules and conditions to participate

- 1. All natural persons of legal age, residing in any country admitted to the Bit2Me platform that can be found at the following link: https://bit2me.com/en-el-mundo, and who meet the following requirements, may participate in the promotion of a week of commission-free purchases on Bit2Me:

- Complete the registration and verification process. We remind you that verification may sometimes take several days and is subject to compliance with current legal regulations and the platform's terms and conditions.
- 4. You must have a balance equal to or greater than 3,000 B2M for 5 consecutive days before the end of the promotion.

The operations that are included in the promotion are all those that can be generated within Bit2Me Wallet and that involve a fee for the user: deposit, purchase, sale, and exchange.

The refund of generated commissions will have an operational limit per user of €1,000.

Bit2Me employees and profiles that have manipulated their participation cannot participate.

Bit2Me reserves the right to make changes to the promotion during its development, if any cause that prevents it from being successfully carried out or in order to improve its progress arises.



### 5.- Cashback refund

All participants who meet the requirements indicated in clause 4 will receive in their Wallet, the 100% cashback discount on the commissions or fees applied to cryptocurrency purchases made on the platform during the period from Monday, July 3rd to Sunday, July 9th (both included). Bit2Me Pro and Bit2Me Earn services are excluded from the promotion.

The discount will be applied to the total fees applied to all cryptocurrency purchases made during the week of July 3rd to 9th. Only the commissions for purchases up to a maximum of €1,000 of operation will be refunded, provided that the amount to be refunded is more than €1. Commissions generated by purchases made from €1,001 during the promotion period will not be refunded.

During the month of July, the refund period for the 100% cashback of the fees charged for purchases executed by the participants during the selected period will begin. Participants will receive the cashback in their euro wallet.

## 6.- Tax Obligations

In accordance with the provisions of the regulations on Value Added Tax and Royal Decree 1619/2012, which approves the Billing Regulations, Bit2Me will issue the corresponding invoice for the entirety of the fees or commissions applied in each transaction carried out on the platform by those clients (individuals) who meet the requirements established in clause 4 of these legal bases during the promotion period.

On the occasion of the refund to clients (individuals) who are beneficiaries of the amount of discounts generated in transactions carried out on the platform during the promotion period, Bit2Me will issue a rectifying invoice, including the amount of the discount actually paid.

In cases where a withholding tax is required in accordance with the regulations of the Personal Income Tax (IRPF), Bit2Me will apply the corresponding withholding tax and make the corresponding payment on behalf of the user. In these cases, Bit2Me will send a certificate to the user indicating the full amount of the prize obtained and the withholding tax applied without deducting the amount of the same.

The client (individual) who is a beneficiary of the discounts applied during the promotion period will be solely responsible for any other tax obligation that may arise from the realization of such discounts and that are different from those described in the previous paragraphs of this section.



Bit2Me is not responsible for any non-compliance by users that may occur due to the lack of communication, information, or submission of the correct tax to the corresponding tax authority.

### 7.- Protection of Personal Data

In compliance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (hereinafter GDPR), Organic Law 3/2018, of 5 December, on the Protection of Personal Data and guarantee of digital rights (hereinafter LOPDGDD) and any other applicable data protection regulations, we inform participants that their personal data will be incorporated into a Database owned and responsibility of BITCOINFORME, S.L., whose purpose and legal basis is the management and participation in the promotion, as well as the maintenance of commercial relations by electronic means based on the legitimate commercial interest of the companies of the Bit2Me Group (you can consult the list of companies at <a href="https://www.bit2me.com">www.bit2me.com</a>).

Promotion participants are entitled to exercise their rights of access, rectification, erasure, restriction, objection and portability of their data, which they may exercise by sending an email to <a href="mailto:rgpd@bit2me.com">rgpd@bit2me.com</a>. Once the purpose of the processing has been completed or the deletion of their data has been requested, they will be blocked and made available to the Administration, Judges and Courts, for the prescription periods of the legal actions that correspond to the treatments produced in defense of our interests.

The participant guarantees that they are the owner of the personal data provided and that it is authentic. It will be the responsibility of the participant for the consequences of providing false data.

Likewise, participants in the promotion are informed that they have the right to withdraw their consent for commercial purposes for the processing of data by the Bit2Me Group, and that they have the right to file a complaint with the Spanish Data Protection Agency <a href="https://www.aepd.es/es">https://www.aepd.es/es</a>.

### 8.- Penalties in case of fraudulent use

Bit2Me will consider as fraud any apparently abusive and/or malicious behavior. Likewise, it will be understood, by way of example but not limited to, that abuse or fraud occurs when a



participant identifies themselves using a false identity or third-party identities without their consent.

Bit2Me is not responsible for possible inappropriate or offensive content that users, at their own risk, may upload on the media that will be used for the development of the promotion.

Bit2Me is not responsible if a user/customer does not pass the process to have their Bit2Me account verified, or if, due to a possible high demand for the verification process of the Bit2Me account, it cannot be completed before the end date of this promotion.

The verification of any of these practices will result in automatic disqualification and prohibition from participating in the promotion.
